विषय-वेलेस वर्क की निविदा आमंत्रित करने संबंधी प्रक्रिया ।

संदर्भ- इस कार्यालय का पत्र क्रमांक 8671/22/वि-12/FA/2013 भोपाल, दिनांक 30/03/2013

साथकार समिति की 43वीं बैठक में लिए गए निर्णय (43/7) अनुसार, सदर्नित पत्र के माध्यम से यह निर्देश जारी किए गए हैं कि वेलेस वर्क की निविदा आमंत्रण प्रस्ताव केवल तब ही महाप्रबंधक यह देखे कि यदि प्रोजेक्ट में एक से अधिक मार्ग हैं-एक वृत्त मार्ग पर आयोजित एवं सोलर वॉल कार्य हो चुका है तो ऐसे मार्गों के संभारण की निविदा प्रेषण से लगाने हेतु प्रस्ताव भेजा जाय तथा जिन मार्गों का कार्य अधूरा है, उनके निर्माण एवं निर्माण पर्याप्त 5 वर्ष संभारण की निविदा लगाने हेतु प्रेषण प्रस्ताव भेजा जाय। इस प्रकार शेष कार्य की निविदा हेतु 2 BOQ एवं निविदा आमंत्रण प्रस्ताव भेजे जाय।

इस संबंध में स्पष्ट किया जाता है कि:

1. जिन मार्गों पर बी.टी. का कार्य, अनुबंध निरस्त (Terminate) करने के, एक वर्ष के अन्दर हुआ है उन मार्गों को शेष कार्य की निविदा में ही सम्मिलित किया जाय तथा उन्हीं के अनुसार BOQ भेजा जाय ऐसे कार्य की निविदाएं वर्तमान में प्रचलित शेष कार्य की निविदा शर्तों के अनुसार, आमंत्रित की जाएगी।
2. जिन मार्गों पर बी.टी. एक वर्ष से पूर्व पूर्ण हो चुका है उन मार्गों के संभारण हेतु प्रेषण से निविदा प्रस्ताव एवं BOQ भेजा जाय। ऐसे मार्गों की निविदा Repair Maintenance के Tender Document (Sep. 2007) की शर्तों के अनुरूप होगी। इसमें केवल Part-I एवं Part-II होंगे। Part-I का स्टैटमेंट एस.ओ.आर. पर तैयार किया जाएगा तथा इस पर प्रतिशत दर पर निविदाएं आमंत्रित की जाएंगी। Part-II की अवधि सम्भवतः 4 वर्ष होगी तथा Part-II का schedule of items निविदा प्रपत्र के Section-7-C के अनुसार होगा जिसमें टेकेंदार रूटीन मेन्टेनेन्स के लिए भी अपनी दर प्रस्तुत कर सकेंगे। इस प्रकार के संभारण कार्य की निविदाओं में, Post 5 Year की NIT में दी गई विशेष शर्तें लागू नहीं होंगी।

उपरोक्तानुसार Maintenance कार्य हेतु जारी की जाने वाली निविदा सूचना एवं विस्तृत निविदा सूचना (Detailed NIT) का पुनरीक्षित प्रारूप संलग्न है तदनुसार ही निविदाएं आमंत्रित की जाएगी।

भविष्य में निर्माण पर्याप्त 5 वर्ष की संभारण अवधि में मूल टेकेंदार द्वारा संभारण कार्य न करने पर शेष अवधि के लिए निविदाएं भी इसी NIT प्रारूप में प्रतिशत दर पर आमंत्रित की जाएगी।

- Bid documents consisting of qualification information and eligibility criterion of bidders, schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can be seen in the office of the tender signed on any working day during office hours upto Tender documents will be issued from General Manager office upto 4 P.M. on on payment of Rs. - Initial Rehabilitation (Part - I) Work consists of construction/repair of roads as per schedule attached and maintenance thereof during defect liability/maintenance period. Contractors are to quote rate as percentage below/above or at par of SOR specified above. The work done by the contractor will be measured and paid as per agreement.
- Part - II Work relates to performance based regular maintenance of roads as per IRC 82 and SP 20 section 1900 which includes, but not limited to, items specified in contract data to clause 16.2.1 of tender document and other relevant clauses of the agreement. Contractor is required to survey the road regularly and attend repair works as and when required and keep the road in good traffic worthy conditions. He will also maintain CDS and Bridges during contract period. Contractor is required to quote lump sum annual per km. rate for such maintenance. Payment will be released

once in 2 months @ 1/6 of the annual rate sanctioned, on the certificate of consultant/Engineer that road has been maintained as per agreement.

6. Names of the roads and their length is given in Annexure to this NIT.

7. a) Bidding documents must be delivered to General Manager, Project Implementation Unit concerned on or before upto 3 P.M. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received on the next working day at the same time and venue.

9. Bids must be accompanied by the earnest money of the specified amount. The earnest money will have to be in any one of the forms as specified in the bidding documents.

10. The bid for the work shall remain open for acceptance for a period of ninety days from the date of opening of bids. If any bidder/ tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.

11. A bidder shall not be permitted to bid for works in the Project Implementation Unit responsible for award and execution of contracts in which his or his spouse's near relative(s) (defined as first blood relations, and their spouses) is/are posted as Accountant/Accounts Officer or as an officer in any capacity between the grades of General Manager and Sub-Engineer (both inclusive).

12. No Engineer of gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. If the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the Government as aforesaid, before submission of the tender or engaged in the Contractor's service his contract is liable to be cancelled and earnest money will be forfeited.

13. Contractors who have been debarred by MPRRDA (list available on our website www.mprda.com) will not be allowed to participate in the tenders unless other wise decided by MPRRDA.
