The Government of India has applied for financing from the World Bank towards the cost of Madhya Pradesh Rural Connectivity Project (MPRCP), and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) shall broadly include, assisting the client to undertake the up-gradation of selected rural roads of gravel standards constructed under CMGSY to black top standards (approximately 10,000 KM) and construction of new rural roads (approximately 3,000 KM) under the projects. The project is scheduled to be completed in a period of approximately 36 months. The broad scope of services will include but not limited to assisting the client in the project management, monitoring, road safety, social/ environment safeguard compliance, financial management and other reporting requirements.

The Project Director, MPRCP, now invites eligible Consulting firms (“Consultant”) to indicate their interest in providing the services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

1. The firm should demonstrate that they have experiences as PMC of at least 2 similar projects costing not less than INR 50million (in terms of consultancy fees) in assisting the client in managing the project implementation funded by Central/State Govt. or World Bank/ADB/multilateral financing agencies in last 5 years;
2. The firm should demonstrate that they have enough capacity (including personnel) in handling project management;
3. The firms should have a total turnover of at least INR 100 million (or equivalent US \$ from consultancy fee) in the last 3 years; and

4. Experience in handling externally aided projects such as the World Bank/ADB and or other multilateral financing agencies will be an advantage.

Expressions of interest (EOI) must include:

- Introductory letter on letter head (with complete contact details – name of contact person, mailing address, telephone, fax, email etc.) explaining how the firm is best to deliver the task
- Organization profile
- Annual Audited Financial statement for the last 3 years;
- Short note on the similar projects implemented by the firm pertaining to the shortlisting criteria along with the contact details of past clients;
- The EOI should contain sufficient supporting documents to substantiate the claim of the Consultant towards their qualification as per the shortlisting criteria.
