The *Government of India* has applied for financing in the amount of **US\$ 350 million** equivalent from the World Bank toward the cost of the *Madhya Pradesh Rural Connectivity Project (MPRCP)*, and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under this project. This project will be jointly financed by the *Government of Madhya Pradesh*.

The project will include the following components: **A) Road Improvement and Mobility Enhancement; and B) Institutional Strengthening**. The scope of work under component A would include Road Network Quality and Connectivity Improvement of 10,000 km of roads including up gradation of rural roads of gravel to bituminous surface and construction of 3,000 km of new roads in MP. Under the component B, the scope of work would include procurement of Project Management Consultants (PMC), procurement of Supervision & Quality Consultant; development of e-based project management system; Road Accident Database Management System; Modernization of Maintenance and Business Practices; Skill Development; Training etc.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank's [Guidelines: Procurement under IBRD Loans and IDA Credits](#) 2011 (updated July 2014), and is open to all eligible bidders as defined in the guidelines. Consulting services will be selected in accordance with the World Bank's [Guidelines: Selection and Employment of Consultants by World Bank Borrowers](#) 2011 (updated July 2014).

Specific procurement notices for contracts to be bid under the World Bank's national competitive bidding (NCB) procedures and for contracts for consultancy services will be announced, as they become available, in [UN Development Business \(UNDB\)](#) and on our website www.mprda.com or www.mpeproc.gov.in & *National and local Newspapers*.
